

### **Ofsted Updates February 2019**

# Since September 2018, published inspection outcomes for Primary Schools in Essex have been as follows:

- 1 category 4 school became a category 3 school
- 2 category 3 schools became category 2 schools
- 16 category 2 schools remained as category 2 schools
- 2 category 3 schools remained as category 3 schools
- 1 category 4 school remained as a category 4 school
- 1 category 1 school became a category 2 school
- 1 category 2 school became a category 3 school

This means that of the 24 schools identified, 3 schools improved their Ofsted grading, 19 remained the same and 2 declined.

### Speech: Amanda Spielman at the 'Wonder Years' curriculum conference -

26 January 2019

The Chief Inspector discussed curriculum and Ofsted's proposed education inspection framework at 'The Wonder Years' Knowledge Curriculum Conference.

'some of you have worried that removing the outcomes judgement might allow schools to take their foot off the pedal when it comes to attainment. But nothing could be further from the truth.

Outcomes have not become irrelevant or unimportant to Ofsted.

Schools should be held to account for how well their pupils achieve and that will not change. What this framework does, however, is to make sure that outcomes are considered in their proper context, to understand whether they have been achieved in a way that sets young people up to succeed in further study and life beyond, rather than just to pass a particular set of exams.

# Amanda Spielman letter to the Public Accounts Committee: short inspection model review

10 December 2018

The Chief Inspector wrote to the Public Accounts Committee (PAC) about the short inspection model and plans to collect more evidence from parents about schools.

'While Parent View has served our inspection needs reasonably well, we are currently in the early stages of a project to replace the existing site with a new service, which better meets parents' needs. The new system is being specifically designed to increase the volume, quality and diversity of views that we collect from parents both during and outside of inspection. This includes considering different platforms, ways of gathering and presenting data and the questions we ask parents.'
