

Ofsted Updates November 2019

Since September 2019, inspection outcomes published in Essex For primary Schools have been as follows:

1 category 4 schools became a category 3 school

6 category 2 schools remained as category 2 schools 1 category 4 school remained as a category 4 school

This means that of the 8 schools identified, 1 school improved their Ofsted grading, 7 remained the same and none declined.

17 Oct 2019 - Early years foundation stage profile (EYFSP) results for the 2018 to 2019 academic year, at national and local authority level.

71.8% of children achieved a good level of development in 2019 – up slightly by 0.3 ppts on 2018.

70.7% of children achieved at least the expected level across all early learning goals (ELGs) - up 0.5ppts compared to last year.

The average total point score was 34.6 out of a maximum 51, the same as 2018.

Some answers to teachers' questions from @ofstednews.

There's no doubt that subject leaders need the support that good CPD and supportive management offers. That's why we look at this under leadership and management, where that responsibility lies.

Progression is pupils knowing more and remembering more and being able to do more. We will not look at internal data to judge this. Lesson visits, discussions with teachers and leaders and pupils, and looking at work provide the evidence.

We don't expect primaries to teach in a secondary way. We don't expect them to be organised in subject departments and we don't expect subjects to be taught in discrete lessons.

Inspectors aren't inspecting 'cultural capital', they're looking at whether the school provides a rich and broad curriculum. A great curriculum builds cultural capital.

Below is Amanda Spielman's conclusion to her commentary;

'Behaviour matters. That is why the EIF contains a separate behaviour and attitudes judgement. We expect that this will bring a greater focus on behaviour on inspection, and allow us to probe more deeply into what schools do and how well this is working.

As we roll out the new framework, we'll be monitoring how well we're able to get under the skin of behaviour management, and to calibrate our inspection findings with what our research shows works best.

Behaviour management will also be a focus in our upcoming initial teacher education inspection framework. It's vital that the next generation of teachers know the important principles of behaviour management, how to teach pupils to behave and how to create an environment that allows them to focus on learning.'
