

## **Updates from Ofsted and the DFE February 2022**

Since 1 September 2021 inspection outcomes published in Essex for primary Schools and academies have been as follows:

8 category 2 schools remained as category 2 schools

I category 4 school remained a category 4 school

3 category I schools remained as category I schools

2 category 3 schools remained as category 3 schools

2 category 3 schools improved to category 2 schools

I category 4 school improved to a category 2 school

I category I school declined to a category 3 school

This means that of the 18 schools identified 14 remained the same, 3 improved and 1 declined.

When the thresholds are reached, education and childcare settings should review and reinforce the testing, hygiene and ventilation measures they already have in place. There is more detail on these in Annex A and in the guidance for each sector.

Settings should seek additional public health advice if they are concerned about transmission in the setting and are considering additional measures, either by phoning the DfE helpline (0800 046 8687, option I) or in line with other local arrangements.

A director of public health or an HPT may give settings advice on whether to take extra action, reflecting the local situation. In areas where rates are high, this may include advice that local circumstances mean that the thresholds for extra action can be higher than set out above. If they judge that additional action should be taken, they might advise the setting to take some or all of the other measures described in this document, for example, extra testing.

All settings should make sure their contingency plans cover how they would operate if any of the measures described were recommended for their setting or area.

Where a staff member has tested positive for COVID-19, education and childcare settings do not need

details of close contacts. However, to ensure eligible individuals identified as a close contact can access Test and Trace Support Payments you may consider providing staff details to the NHS Self Isolation Hub when:

- a staff member who was in close contact with the person testing positive has indicated they are not exempt from self-isolation, but the person testing positive was unable to provide that person's details to NHS Test and Trace
- it is particularly difficult for the person testing positive to identify or provide details of some members of staff they were in contact with, for example, temporary workers such as supply staff, peripatetic teachers, contractors or ancillary staff

- update to tracing close contacts and isolation section to clarify the advice for under 5s
- update to face coverings section to reflect removal of recommendation to wear face coverings in classrooms and communal areas
- update to mandatory certification section to reflect that this will no longer be in place from 27 January
- update to workforce section to reflect that government is no longer advising people to work from home if they can

As of January 2022, there's been 2 validation rounds. As a large number of self-assessment submissions almost met the <u>16 essential core criteria</u>, the panel is carrying out an additional resubmission exercise in mid-February. This means the <u>list of validated phonics</u> <u>programmes</u> will likely be updated to include more programmes in late February. This will ensure that schools have a wide as possible choice of validated SSPprogrammes, before the end of the 2021-22 financial year.
