

# **Updates from Ofsted and the DFE February 2023**

# Since 1 September 2022 inspection outcomes published in Essex for primary Schools and academies have been as follows:

49 schools that were category 2 schools remained as category 2 schools 2 schools that were category 4 schools remained as category 4 schools 4 schools that were category 1 schools remained as category 1 schools

4 schools that were category 3 schools are now category 2 schools 1 school that was a category 4 school is now a category 2 school

2 schools that were category 3 schools are now category 2 schools

3 schools that were category 1 schools are now category 2 schools 2 schools that were category 3 schools are now category 4 schools 2 schools that were category 2 schools are now category 3 schools

This means that of the 69 schools identified 55 remained the same, 7 improved and 7 declined.

Ofsted want to maintain school inspection activity as far as possible in February and March, while responding sensitively to local circumstances. So, they will schedule school inspection notifications and on-site inspections to avoid strike days.

For example, to avoid the strike action taking place on 1 February, they will notify schools of their inspection on Tuesday 31 January. On-site inspection activity will then take place on Thursday 2 February and Friday 3 February.

Ofsted has published data on school inspections carried out up to the end of December 2022.

It shows that around 89% of all 22,000 schools were good or outstanding at their most recent inspection. This is an increase from 86% in August 2019 and 88% in August 2022. The data also shows that schools previously judged requires improvement (RI) have done particularly well last term, as 78% of those inspected improved to good, compared with 70% in 2021/22.

The vast majority of formerly outstanding schools visited this year had been exempt from routine inspection between 2012 and 2020. Since the government lifted the exemption, most of these schools have lost the top grade on reinspection. However, a slightly higher proportion of the previously exempt schools have remained outstanding this year compared with 2021/22 (21% v 17%), and a lower proportion were found to require improvement or to be inadequate (13% v 21%).

Plans do not need to be written down just for inspectors' benefit. You can explain to inspectors what you want children to learn and why. That said, if you choose to make written plans because it works better for you, that is absolutely fine as well. Just don't do it because you think we want to see them.

This leads me onto one of the other commonly asked questions about preparing for inspection:

'Should I have a folder of paperwork marked 'Ofsted'?'

Despite what you may have heard, inspectors do not want to see a particular amount or type of paperwork. The early years foundation stage (EYFS) sets out what you must record. You should use whatever approach to paperwork suits you and you are free to file it however you like. But please do not be offended if our inspectors would rather understand your plans, policies and procedures by talking about them rather than reading them. We've told inspectors not to ask to see paperwork unnecessarily.

If you want to find out about what will happen on an inspection, have a look online. We've refreshed our education inspection framework (<u>EIF) and EYFS page</u>, where we address individual aspects of inspection. And if parents of the children you look after have questions, you can point them to the <u>inspection guides that we've recently published specifically for them</u>.

## Providing remote education: guidance for schools

## Scenarios where remote education should be considered

Circumstances where it might not be possible for pupils to receive in person education fit into two broad categories:

- School closures or restrictions on attendance, where school access for pupils is restricted
- Individual cases where a pupil is unable to attend school but is able to learn
