

Updates from Ofsted and the DFE January 2024

Since September 2023, inspection outcomes published for primary schools in Essex have been as follows:

44 schools that were category 2 schools remained as category 2 schools

2 schools that were category 3 schools remained as category 3 schools

4 schools that were a category 1 schools remained as category 1 schools

4 schools that were category 3 schools are now category 2 schools 3 schools that were category 4 schools are now category 2 schools

3 schools that were category 2 schools are now category 3 schools

1 school that was a category 2 school is now a category 4 school

3 schools that were category 1 schools are now category 2 schools

This means that of the 62 schools identified 47 remained the same, 8 improved and 7 declined.

Recently announced changes to school inspections include:

- scheduling inspectors to return more quickly to schools graded inadequate because of ineffective safeguarding but which are otherwise performing well
- changes to Ofsted's complaints process following a consultation held last year
- the introduction of a duty helpline to take calls directly from providers during and after an inspection
- changes to school handbooks, to make clear that school leaders can be joined by colleagues in meetings with inspectors, and can share inspection outcomes with colleagues, family, medical advisers and their wider support group, before sharing with parents
- delivering seminars across all Ofsted's regions to support leaders of previously exempt outstanding schools ahead of their next inspection

Further changes will be announced soon – as Ofsted continues to respond to the coroner's findings and her regulation 28 report.

Education update for headteachers: academic year 2023 to 2024

Published 24 November 2023- Ofsted

A new newsletter from Ofsted providing headteachers and school leaders with developments taking place in inspection policy.

On 24 November, Ofsted announced that they will implement all 4 changes proposed in their recent consultation on post-inspection arrangements and complaints. The changes are

- enhanced on-site professional dialogue during inspection to help address any issues
- a new opportunity for providers to contact Ofsted the day after an inspection if they have unresolved concerns

- new arrangements for finalising reports and considering formal challenges to inspection outcomes
- direct escalation to the Independent Complaints Adjudication Service for Ofsted (ICASO) and a periodic review of closed complaints using external representatives

The changes will come into effect in January 2024 and April 2024.

Major national drive to improve school attendance

Published 8 January- DFE

A national communications campaign on the importance of attendance is also launching today (8 January) targeting parents and carers. Under the strapline '<u>Moments Matter, Attendance Counts</u>' it outlines the importance of attendance for attainment, wellbeing, and development as well as signposting to advice for further support.

Key advice includes a recent letter <u>from the Chief Medical Officer</u> that outlines best practice when it comes to attendance and illness. The intention is to ensure that parents have the guidance they need when it comes to making decisions when deciding to send their child to school or when to keep them home.

The government has also committed to further legislation in the coming months that will mean all schools will be required to <u>share their daily school registers</u>. This, together with reforming pupil registration practice, will modernise how schools record and share data on attendance and support them to understand what is driving absence in their school and provide early support and intervention where pupils are displaying worrying trends of absence.

Monitor your school attendance data: If your school is sharing daily attendance data with the Department for Education, you can get access to the free Monitor Your School Attendance tool. There are many benefits, such as:

- Track pupil attendance
- Identify pupils needing support
- Save time building attendance reports
- Get trend insights for different pupil cohorts
- Compare your school's attendance within your local authority

Education staff wellbeing charter

Updated 15 January 2024- DFE

Added a link in the "Monitoring and evaluation section' to the DFE's progress update on its commitments in the education staff wellbeing charter.

Co-created with the sector, the <u>Education Staff Wellbeing Charter</u> sets out shared commitments to promote, protect and enhance the wellbeing of staff. The charter can be used to create a wellbeing strategy and schools are invited to <u>sign up</u>.

There are a range of wellbeing support options currently available, including:

- Access to free one-to-one professional supervision for school leaders through a <u>funded scheme</u> <u>delivered by the Education Support charity</u>. Over 1,400 leaders have benefitted from the support so far.
- <u>A grant</u> to fund school or college mental health lead training to embed an effective <u>whole school</u> <u>or college approach to mental health and wellbeing</u>.

The DFE are expanding the mental health and wellbeing support for school and college leaders, and from April 2024 will begin funding a three-year mental health and wellbeing support package. The package will provide professional supervision and counselling, ensuring more school and college leaders are able to access support.

Early years foundation stage (EYFS) statutory framework

The following updates have been made

9 January 2024- Updated the 2 statutory framework documents to clarify providers' responsibilities on paediatric first aid training. In the framework for childminders we have also edited paragraph 3.24, in the section on training, support and skills.

4 January 2024- Removed 'Statutory framework for the early years foundation stage (applies until 3 January 2024)' and amended the text to reflect this.

19 December 2023- Added summaries of changes from the September 2023 guidance to the January 2024 guidance.

8 December 2023- Added the 'EYFS statutory framework for childminders' and the 'EYFS statutory framework for group and school-based providers'. You should use these documents from 4 January 2024.
