## Children missing education

Updated 8 September 2025- DFE

The DFE have updated the statutory guidance. The update aims to address inconsistencies in practice and add clarity, including on schools and local authorities working together to identify and support children missing education. The document is now issued as statutory for schools as well as local authorities. Existing legislation already requires schools to carry out these responsibilities. They have also added a summary of responsibilities, and a policy and procedure checklist.
